The Liaison will meet with the young adult while still in custody to formulate a viable plan for when the young adult leaves the child welfare system. In their work the Liaison will place a strong emphasis on engaging transition age youth and permanency planning.

- Makes at least monthly visits to the young adults living arrangement.
- Provides hands-on, in-home support and training to Bridges young adults, in skills such as but not limited to home maintenance, budgeting, relationship/communication skills, anger management, obtaining community services, job and apartment seeking, navigating the different systems in Ohio, education options and more.
- Attends court as needed.
- Works with housing entities to ensure safe and stable housing for Bridges young adults.
- Participates in program development.
- Ensure all service providers linked with Bridges young adults are providing quality services.
- Attends and participates in meetings and trainings for the Bridges program.

- Complete all required paperwork per State ORC, ODJFS Bridges contract and other required paperwork.
- Establish and maintain a database for tracking timelines and collection of data for the Bridges program.
- Provide monthly statistics on Bridges as required by supervisor.
- Documentation of all client contact and on-going communication with collaterals.
- Completes audits of Bridges case as requested by supervisor.
- Completes all assessments, treatment plans and reviews for young adults in Bridges programing. Ensures all are young adult driven.
